

## Connections at MetroWest Work From Home Contest Rules

NO PURCHASE IS NECESSARY TO ENTER OR WIN. MULTIPLE CONTEST SUBMISSIONS DOES NOT INCREASE THE CHANCES OF WINNING.

1. Eligibility: This Campaign is open only to MetroWest residents and who are 16 years of age or older as of the date of entry and is void where prohibited by law. Employees of Connections at MetroWest, its affiliates, subsidiaries, advertising and promotion agencies, and suppliers, (collectively the “Employees”), and immediate family members and/or those living in the same household of Employees are not eligible to participate in the Campaign. The Campaign is subject to all applicable federal, state, and local laws and regulations. Void where prohibited.

The entry must fulfill all Campaign requirements, as specified, to be eligible to win a prize. Entries that do not adhere to the rules or specifications may be disqualified at the sole discretion of Connections at MetroWest. You may enter only once. You may not enter more times than indicated by using multiple email addresses, identities, or devices in an attempt to circumvent the rules. Connections at MetroWest reserves the right, in its sole discretion, to disqualify any individual who tampers or attempts to tamper with the entry process or the operation of the Campaign or website or violates these Terms & Conditions.
